HOW TO COMPLETE THE TRANSFER FORM FOR NON-MARKET TRANSACTIONS WHEN TRANSFERRING SECURITIES IN A LISTED COMPANY

1. FULL NAME OF ASX COMPANY OR TRUST

The full name of the ASX Company or Trust in which securities are held.

2. DESCRIPTION OF SECURITIES (including security code)

e.g. Fully Paid Ordinary Shares, 9% Unsecured Convertible Notes, Options (including expiry and exercise price) etc...

3. QUANTITY

Number of securities being transferred.

4. FULL NAME OF TRANSFEROR/S OR SELLER/S

Full names must be included together with any designation (if applicable).

Please refer below for the documentary proof of identity that must be lodged with a completed transfer form.

5. SECURITYHOLDER REFERENCE NUMBER

This number must be quoted when transferring securities on the issuer sponsored subregister.

6. CONSIDERATION

Is the full amount paid in settlement of the transfer of securities. Purchases should reflect the market price of shares as at the date of purchase. Market values are quoted in the daily newspapers.

7. DATE OF PURCHASE

Insert date of purchase or completion of the transfer.

8. FULL NAME AND ADDRESS OF TRANSFEREE/S OR BUYER/S

Insert the full names of buyer/s (a maximum of three joint holders).

Securities may not be registered in the names of a firm or business name, an estate or deceased person, a minor, a fund or a trust.

SELLER AND BUYER PROOF OF IDENTITY

As a corporation (ASIC or foreign registered) you must provide

- Certified copy of certification of registration issued by ASIC or other regulator
- Certified copy of a licence issued by a domestic or foreign regulator

If the buyer is an existing holder in the company and is registered on the Issuer Sponsored subregister, please quote the existing SRN.
